MALARIA ELIMINATION: SANWO-OLU ADVOCATES 'TEST-BEFORE TREATMENT' STRATEGY

DATE: 4TH MARCH 2025

At Eko Hotels and Suites, Lagos, Governor Babajide Sanwo-Olu and Dr. Iziaq Salako, Minister of State for Health and Social Welfare, launched the "Pathway to Malaria Pre-Elimination and Digitization Program." The initiative aims to tackle malaria through digital innovation and partnerships. Governor Sanwo-Olu emphasized the socioeconomic burden of malaria, stressing its eradication as an economic priority. HFN President Njide Ndili and BOT member Clare Omatsaye delivered goodwill messages, joined by other industry leaders.

HFN, represented by Mrs. Njide Ndili (President HFN), participated in the "IFC-World Bank Pharma CEOs Roundtable Meeting" to address key challenges in local pharmaceutical manufacturing.

Discussions focused on pain points and policy solutions, with a commitment to driving favorable reforms.

During the discussions, the International Finance Corporation (IFC) expressed its willingness to support local manufacturers with funding to strengthen local production and boost the industry's growth

In a significant step forward, a committee has been established to advance recommendations from the roundtable, with HFN appointed as a key member to ensure private sector interests are well represented.

At the Nigerian Investment Promotion Commission (NIPC), HFN met with Executive Secretary Aisha Rimi to explore strategies for incentivizing the healthcare sector and attracting increased Foreign Direct Investment (FDI). The dialogue underscored the importance of creating an enabling environment for investment and innovation within the health ecosystem.

The leadership also engaged with Dr. Jide Idris, Director General of the Nigeria Centre for Disease Control (NCDC), where the conversation centered on pandemic preparedness, disease surveillance, and the critical role of private sector actors in emergency response and public health interventions.

HFN'S ADVOCACY TRIUMPH: ZERO VAT AND DUTIES ON ACTIVE PHARMACEUTICAL INGREDIENTS (APIS)

DATE: 13TH MARCH 2025



HFN's sustained advocacy efforts have yielded a significant policy milestone with the successful implementation of the Executive Order on the removal of Value Added Tax (VAT) and import duties on Active Pharmaceutical Ingredients (APIs). This breakthrough was achieved through an official approval granted by the Federal Ministry of Finance to the Nigeria Customs Service. The implementation of this policy took effect on March 25th, 2025, and will remain enforced for a period of two years. By eliminating VAT and duties on APIs, the cost of producing essential medicines is expected to reduce significantly. This development is a critical step toward improving medicine affordability, expanding access to quality healthcare, and advancing health equity for all Nigerians.

HFN President, Mrs. Njide Ndili delivered a compelling goodwill message emphasizing the pharmaceutical sector's vital role in achieving Universal Health Coverage (UHC). She highlighted the need for stronger collaboration between industry leaders, government agencies, and private-sector stakeholders to drive sustainable healthcare solutions.







A key focus of her address was HFN's ongoing advocacy efforts, particularly the recent Ministry of Finance guidelines supporting the Presidential Executive Order on zero tariffs on local manufacturing—a significant milestone driven by the Presidential Initiative for Unlocking the Healthcare Value Chain (PVAC).

WORKSHOP ON THE FMOH ALIGNMENT TOOL

DATE -: MARCH 18-19TH, 2025



Jointly organized workshop by the FMOH and World Bank/IFC, examined stakeholder feedback on the Federal Ministry of Health's One Plan, One Budget, One Report framework. The primary goal was to evaluate inclusivity, identify gaps, and ensure diverse stakeholder representation.

HFN represented by Dr. Benson Ayodele, 1st Vice President, highlighted the absence of key state and local government stakeholders, particularly the Nigeria Governors' Forum (NGF) and the Association of Local Governments of Nigeria (ALGON). The review highlighted that the framework does not adequately integrate private sector contributions. This omission presents a significant gap, as private sector involvement is critical for resource mobilization, innovation, and expanded healthcare service delivery.

The workshop underscored the importance of inclusive policy-making and the need for a structured engagement strategy for both government and private sector stakeholders.

COMMITTEE PRESENTS REPORT ON NATIONAL HEALTH FACILITY REGULATORY AGENCY TO MINISTER OF STATE FOR HEALTH

DATE: 28TH MARCH 2025



The committee inaugurated on 4th September 2024 to establish the National Health Facility Regulatory Agency (NHFRA) has officially submitted its report to the Minister of State for Health, Dr. Iziaq Kunle Salako.

The report was formally presented by Dr. Richard Ajayi, the chairman of the committee, who highlighted its key recommendations.

The committee was tasked with developing a governance structure, operational framework, and legislative guidelines for NHFRA.

NHFRA is aimed at enhancing healthcare facility standards, improving service delivery, and ensuring greater accountability in the health sector. It will also focus on establishing strong regulatory mechanisms and collaborating with state agencies and other professional regulatory bodies to enforce compliance and improve healthcare quality nationwide. Members of HFN on the committee included Mrs. Njide Ndili (President HFN), Dr. Benson Ayodele Cole (1st Vice President HFN), Mr. Tosin Runsewe, CEO of AfyA Care and Chairman of Evercare and Dr. Damilola Matti, Executive Manager of the Society for Quality in Healthcare in Nigeria.

The Minister commended the committee's efforts and reiterated the government's commitment to strengthening healthcare regulations.

The next steps will involve a thorough review of the report, followed by the drafting of a bill to formalize the establishment of NHFRA.







HFN NEW EXCO STRATEGY RETREAT - 2025

DATE: 27TH MARCH 2025

The HFN EXCO Retreat was a deep strategic session with the Excos and Secretariat present. The 2-day Retreat, which held the objective to articulate HFN's Vision for the next three years, consolidate advocacy priorities, strengthen HFN's Sustainability, and drive stakeholder engagement, featured several key discussions and presentations.



The retreat concluded with a clear set of outcomes and next steps, including:

- Intensifying advocacy visit.
- Identifying resource personnel for engagement with HFN members.
- Schedule and follow up on policy visits.
- Schedule stakeholder regional meetings.
- Exploratory meetings with identified partners with key asks in view.
- Ensuring HFN's long-term sustainability through access to funds and increase in membership strength amongst others.

FEDERAL GOVERNMENT'S DUTY VAT WAIVERS ON PHARMACEUTICAL MATERIALS



The Healthcare Federation of Nigeria (HFN) is delighted to share a major milestone in its ongoing commitment to improving Nigeria's healthcare landscape.

Thanks to HFN's relentless advocacy, the Federal Ministry of Finance has released implementation guidelines for the Presidential Executive Order aimed at boosting local production of healthcare products and reducing the cost of essential equipment and consumables.

Key highlights of these guidelines include VAT and import duty exemptions for critical raw materials used in pharmaceutical manufacturing.

This groundbreaking initiative is a gamechanger, encouraging local investment and enhancing access to vital medicines for all Nigerians. This milestone is the result of sustained advocacy effort led by HFN alongside other key stakeholders, to enhance the local production of life-saving medical commodities and improve healthcare delivery nationwide.

Stay tuned for further updates from the Nigeria Customs Service (NCS) as HFN continues to provide guidance on accessing and implementing this transformative program.

INAUGURATION OF THE IMPLEMENTATION COMMITTEE FOR THE NATIONAL STAKEHOLDERS DIALOGUE ON POWER IN THE HEALTH SECTOR

DATE: 28TH MARCH 2025



Dr. Iziaq Kunle Salako officially inaugurated the Implementation Committee for the National Stakeholders Dialogue on Power in the Health Sector.

This committee is tasked with convening a National Stakeholders Dialogue, implementing key recommendations, and mobilizing resources for the sustainable electrification of healthcare facilities. The committee, chaired by the Honourable Minister of State for Health, includes distinguished members such as:

Dr. Babatunde Ipaye (Vice Chairman), Mrs. Njide Ndili (President of HFN), representatives from the Ministry of Health, Ministry of Power, NPHCDA, REA, NSIA, World Bank, WHO, UNDP, Global Fund, CHAI, PharmAccess, and NESG.

This initiative is a major step toward ensuring uninterrupted power for better healthcare delivery in Nigeria!


