28TH NUNSA ANNUAL GENERAL ASSEMBLY AND SCIENTIFIC CONFERENCE

DATE: APRIL 7TH 2025

At the 28th NUNSA Annual General Assembly and Scientific Conference themed "Empowering Nurses: A Catalyst for Sustainable Healthcare in Africa," HFN President Njide Ndili delivered a compelling address emphasizing the indispensable role of nurses in Nigeria's healthcare landscape. In her remarks, she stressed that nurses lie at the heart of primary healthcare, delivering essential services ranging from immunizations and maternal and child care to health education and community outreach, particularly in rural and underserved areas.



Furthermore, she addressed the significant challenges faced by the profession, such as workforce shortages, limited opportunities for professional development, inadequate working conditions, and low compensation, and noted the existence of gender disparities in leadership.

She advocated for investments in nursing education, leadership training, and policy reforms, asserting that empowering nurses is essential to creating a resilient healthcare system that delivers improved outcomes for communities across Africa. Her remarks served as a clarion call for all stakeholders to unite in strengthening the nursing profession. Her clear vision highlights nurse empowerment as essential for transforming Africa's healthcare systems.

Represented by Chinyere Okorocha, Public Relations Secretary, and Mr. Ayodeji Oni, B.Pharm, former Executive Secretary, HFN joined Nigerian physicians, healthcare professionals, and public sector leaders from across the diaspora to discuss transformative solutions for Nigeria's evolving healthcare ecosystem.

DATE: 10TH APRIL, 2025

Dr. Ayodele Benson-Cole, 1st Vice-President of HFN, delivered a compelling goodwill message at the Hallmark HMO Stakeholders Meeting 4.0, themed "Influence of Global Downturn on Health Insurance Coverage for SMEs." He emphasized the event's critical timing and the urgent need for innovative measures to protect both citizens and businesses amid economic challenges. Dr. Benson-Cole highlighted HFN's pivotal role in championing health insurance as a key pathway to achieving universal health coverage.

He urged HMOs to move beyond mere compliance by implementing strategies that engage the informal sector and underserved communities through innovative approaches. He also called for customer-centric technological advancements to enhance affordability and accessibility for SMEs, which are vital to Nigeria's economy. Additionally, he framed expanding SME health insurance as a moral imperative and matter of social justice, calling for cross-sector collaboration and strategic partnerships to build a sustainable, future-proof system. He remains optimistic about driving systemic improvements.





THE WORLD BANK WESTERN & CENTRAL AFRICA (AFW) REGIONAL HEALTH ENGAGEMENT STRATEGY

DATE: APRIL 10TH, 2025



President of the Healthcare Federation of Nigeria (HFN), Njide Ndili, Country Director, PharmAccess Nigeria, joined health experts from West and Central Africa in Accra for a high-level consultation hosted by The World Bank Group.

The session forms part of the ongoing process to shape the Western & Central Africa (AFW) Regional Health Engagement Strategy across 3 major pillars, #FrontlineFirst, #FixingFinance, and #FutureIt, expected to launch in June 2025.



Njide emphasized the essential role of the private sector in supporting governments to implement this strategy, urging intentional collaboration to ensure ownership, impact, and sustainability.

She also highlighted:

- The need for capacity building for policymakers and government officials, equipping with the appropriate them effective frameworks tools for and implementation of the strategy.
- The importance of cross-sectoral and agency collaboration, as health outcomes are influenced by factors from other sectors
- The need to contextualize the strategy to each country's unique challenges and systems

The event underscored HFN's commitment to regulatory clarity, institutional resilience, and equitable access to quality care across Nigeria.

Mrs. Chinyere Okorocha, Head of Sectors Jackson, Etti & Edu and Publicity Secretary HFN, opened the session by underscoring the urgent need for Nigerian healthcare institutions to adopt systems that qo beyond basic emphasising compliance, sustainability, professional credibility, and improved patient outcomes. She encouraged participants to walk away with at least one actionable improvement for their institutions.

Njide Ndili, HFN President and Country Director PharmAccess Nigeria, shed light on key HFN priorities: harmonised regulatory standards, decentralised care models, and closing rural healthcare gaps through hub-and-spoke systems and telemedicine. Member Takeaways & Action Steps:

- Embed compliance into daily operations with routine SOP reviews, legal audits, and professional indemnity cover.
- Strengthen operational controls by standardising credentialing, outsourcing protocols, and crisis-response plans.
- Enhance diagnostic quality through ISOaligned processes, supply-chain checks, and robust data-privacy safeguards.

YOUNG FEMALE INNOVATORS SHINE AT HFN WOMEN'S FORUM 2025 PITCHATHON

DATE: 25TH APRIL, 2025



As part of the Healthcare Federation of Nigeria's (HFN) 10th Anniversary celebrations, the HFN Women's Forum held a special ceremony in Lagos to honour the winners of its 2025 Pitchathon. This flagship initiative aims to promote innovation, entrepreneurship, and leadership among young women in Nigeria's healthcare sector.

The Women's Forum, launched during HFN's 2023 Annual Conference, was created to close the leadership gap facing women in healthcare. Although women make up over 70% of Nigeria's healthcare workforce, they remain significantly underrepresented in leadership and decisionmaking roles. Through programs like the Pitchathon, the Forum offers young female entrepreneurs critical support in the form of mentorship, exposure, and access to growth resources.

In her opening remarks, HFN President Mrs. Njide Ndili praised the creativity and impact of the participants, many of whom are still students. "It's inspiring to see young women leading solutions to some of our most pressing healthcare challenges," she said.

Dr. Olayemi Dawodu, CEO of Cerba Lancet and Head of the Pitchathon Subcommittee, shared that over 50 entries were received, with five outstanding finalists selected to pitch their ideas at the HFN Annual Conference. Winners were chosen based on innovation, feasibility, relevance, and scalability.

The winners are:

Ist Place – CODE-RED NIGERIA (Anita Orji & Oluwakemi Ifedoyin): A digital platform that connects emergency seekers to hospitals and emergency services in real-time, reducing delays and saving lives.

2nd Place – HerAid (Muktarah Banire & Zoheeroh Andu): A nonprofit improving maternal and child health through advocacy and communitybased interventions.

3rd Place – MyDrugAida (Erinibi Salami): A cloud-based system linking electronic medical records across facilities to improve continuity and quality of care.

HFN Public Relations Secretary Mrs. Chinyere Okorocha emphasized the importance of nurturing early-stage innovations to shape the future of healthcare in Nigeria.

The HFN Women's Forum remains committed to building leadership capacity, business skills, and networks for women across the sector—ensuring that more women are not only part of the system but driving meaningful change within it.

HEALTH-ENERGY INITIATIVE: COMMITTEE MANDATE AND HFN SURVEY INSIGHTS

In April 2025, the Federal Ministry of Health and the Ministry of Power convened an Implementation Committee on Power Solutions for the Health Sector to confront Nigeria's chronic energy insecurity in healthcare. Chaired by Dr. Iziag Adekunle Salako, the 15-member including the President of HFN, Njide Ndili, Country Director, PharmAccess.

The committee will:

- Audit existing energy assets and consumption across public health facilities.
- Convene National Stakeholders a Dialogue-bringing together clinicians, engineers, financiers and regulators.
- Model demand profiles and map offgrid and grid-tied solutions (mini-grids, solar-hybrid, energy efficiency).
- Identify financing structures (blended finance, concessional loans, PPPs) and legislative amendments draft to establish a Health Energy Fund and universal electrification standards.

Healthcare Federation of Nigeria (HFN) surveyed 36 private facilities in April 2025 to quantify energy use, costs, and cleanenergy readiness. The sample included 16 hospitals (44%), 9 pharmaceutical firms (25%), 4 NGOs (11%), 2 diagnostic centers (6%), and smaller operators (clinics, nursing agencies, telemedicine, equipment distributors). Data collection focused on:

- Power sources and reliability
- Hours of grid supply vs. generator usage
- Monthly kWh consumption and naira costs
- Engagement with financing programs
- Top energy-consuming equipment

Key Findings

- Power Mix & Reliability: 94% rely on the national grid, but only 14% receive 20-24 hours/day; 67% use diesel generators (primary or backup), driving up operational costs. Solar PV penetration stands at 31%, hybrid systems at 14% and battery-only inverters at 11%.
- Supply Gap: Although 58% of facilities require 20-24 hours of power, just 14% achieve this. A further 39% need 12-20 hours but fall short, exacerbating reliance on generators.
- Consumption & Cost: One-third consume 2,000-10,000 kWh/month; 12.5% exceed 30,000 kWh (large hospitals). Over twothirds spend up to #5 million/month on both grid electricity and generator fuel. Energy represents 5-15% of operating expenses, peaking at 25%.
- Operational Impact: 74% report higher patient fees; 46% cite service-quality declines: 34% have postponed expansions. Major energy drains include conditioning (89%), medical air equipment (44%) and lighting (33%).
- Clean-Energy Readiness: Only 11% have pursued grants, yet 62% prefer solar PV, 18% hybrid systems, signaling strong interest hampered by financing barriers.





HFN ENERGY USAGE SURVEY

DATE: APRIL 30TH, 2024

Electricity isn't just a utility—it's a lifeline.

From powering ventilators and life-saving equipment to ensuring reliable diagnostics and maintaining cold chains for medicines, uninterrupted energy is the backbone of modern healthcare delivery. Without it, quality care is compromised, and lives are put at risk.

Recognizing this, the Honourable Minister of State for Health constituted a committee to develop sustainable power solutions for public tertiary hospitals. As a member of this committee, the Healthcare Federation of Nigeria (HFN) saw an urgent need to incorporate the private sector's perspective into these discussions.

PRESIDENTIAL FISCAL POLICY AND TAX REFORMS COMMITTEE

DATE: 29TH APRIL, 2025

The Presidential Fiscal Policy & Tax (PFPTRC). Committee Reforms in collaboration Babcock with **Business** School, convened a workshop on the 29th April 2025 at the Oriental Hotel, with policymakers, academia, and private sector leaders to assess stakeholders' readiness for effective implementation of the ongoing fiscal and tax reforms.

The workshop provided a crucial platform for advocacy and inclusion in Nigeria's ongoing fiscal and tax reform agenda.

HFN represented by Pharm. Ayodeji Oni (former HFN Executive Secretary) held a brief discussion with PFPTRC Chairman, Mr. Taiwo Oyedele, during which they emphasized the need for healthcare representation in reform implementation plans.

HFN highlighted the importance of supporting previously submitted policy recommendations, including the effective implementation of the Sugar-Sweetened Beverage (SSB) tax and the call for zero taxation on medical and emergency equipment. The exchange underscored HFN's commitment to ensuring that private sector healthcare voices are actively involved in shaping tax policies that impact health systems and service delivery across the country.

HFN ABUJA STAKEHOLDERS MEETING

DATE: APRIL 30TH, 2024



The HFN Abuja Members Meeting, held at NISA Wellness Retreat in Abuja, offered a comprehensive review of HFN's advocacy and strategic initiatives for Nigeria's private healthcare sector. President Njide Ndili opened the meeting by charting HFN's evolution from its inception to becoming a unified voice for private healthcare providers in policy dialogues. Key advocacy achievements discussed included legislative and policy initiatives-such as submitting recommendations to the NHFRA, tracking policy bills in the House, and effectuating an executive order to exempt VAT and import duties on Active Pharmaceutical Ingredients-aimed at reducing costs and bolstering local manufacturing.

The meeting also highlighted energy reform efforts through surveys of private facility energy usage and celebrated women's empowerment Women's Forum initiatives via the HFN Pitchathon. Contributions from leadership emphasized the integration of private hospitals in national pandemic responses, the need for a dedicated regulatory framework, and enhanced stakeholder engagement. Open discussions focused on adapting to digital health systems, addressing inefficient healthcare spending, and supporting local manufacturing. Overall, the session reaffirmed а commitment to collaborative, innovative strategies for a sustainable, future-proof healthcare ecosystem in Nigeria.





COUNTRY CONSULTATION FOR THE GLOBAL FINANCING FACILITY (GFF) ON DEVELOPMENT OF THE NEW GFF 2026-2030 STRATEGY.

DATE: MAY 12TH, 2025



In a bid to strengthen collaboration and enhance strategic decision-making, the Facility (GFF) Global Financing an international partnership aimed at improving health and nutrition outcomes for women, children, and adolescents in low and middle-income countries, convened a country consultative meeting, at the World Bank office in Abuja.

Njide Ndili, President of HFN, participated virtually and underscored the importance of structuring GFF interventions into distinct focus areas, or "buckets," to ensure the effective delivery of quality healthcare and address existing gaps in demand. She also advocated for GFF's support in assisting state governments to implement the Quality Improvement Plan Program within their healthcare delivery systems.

Dr. Ayodele Benson Cole, First Vice President of the Healthcare Federation of Nigeria (HFN), attended the meeting in person and spoke on the vital role of private sector participation in the GFF program. He emphasized the broad impact of leveraging private sector mechanisms to enhance health outcomes across the population.

On behalf of HFN, he presented a position paper to the GFF team, outlining the value of integrating the private sector into the GFF 2026–2030 strategy. The paper highlighted several key areas, including:

- The strategic role of the organized private sector in advancing RMNCAH+N (Reproductive, Maternal, Newborn, Child, and Adolescent Health, plus Nutrition) outcomes
- A case study of the Delta State Primary Healthcare (PHC) revitalization partnership
- Successful private sector healthcare models from other countries
- Targeted recommendations for strengthening RMNCAH+N through private sector engagement
- Strategic focus areas for the GFF 2026-2030 strategy
- A proposed strategic shift to better align GFF's future direction with private sector capabilities.



HEALTH EMERGENCY INITIATIVE (HEI), FIRST RESPONDERS TRAINING PROGRAMME

DATE: MAY 16TH, 2025

Njide Ndili, President of the Healthcare Federation of Nigeria (HFN), attended the grand finale of the First Responders Training Programme, organized by Health Emergency Initiative (HEI), a member of the Federation.

The programme trained secondary school students and teachers across Lagos, Kwara, and Rivers States in essential emergency response skills, including CPR, First Aid, and Trauma Care.

A major milestone announced at the event was the official approval by the Lagos State Ministry of Education to incorporate First Responders Training into the secondary school curriculum a significant step toward building a more emergency-ready generation.





HEI, led by Executive Director Paschal Achunine, continues to drive impactful health interventions across Nigeria.

- * They have successfully trained 126,000 individuals across urban, rural, and underserved communities.
- * 9,622 real-life emergencies have been addressed by these trained first responders.
- * 3,750 accident and fire victims have been supported, with a commendable 72% survival rate.

HFN celebrates the Health Emergency Initiative (HEI) for its unwavering dedication to saving lives and improving emergency care in Nigeria.

On May 19, 2025, Inspiration FM 92.3 MHz in Lagos welcomed Njide Ndili, President of the Healthcare Federation of Nigeria (HFN), for a live radio conversation. The interview, hosted by the station's flagship morning show, centered on the upcoming HFN Healthcare Leadership Conference and the strategic partnership between HFN and WHX Lagos 2025.

Njide Ndili began by outlining HFN's mission to catalyze private-sector-driven solutions that bolster Nigeria's health system. She highlighted how the Healthcare Leadership Conference would convene stakeholders—from policymakers and hospital administrators to start-up innovators—to chart a unified path toward Universal Health Coverage (UHC).

- Conference Objectives
 - Accelerating progress on UHC through collaborative frameworks
 - Showcasing scalable innovations in digital health, supply chains, and financing
 - Strengthening health sovereignty via integrated public-private models

- Public-Private Collaboration
 - WHX's role as innovation curator, connecting Nigerian health entrepreneurs to global investors
 - Joint workshops designed to co-create policy recommendations for government adoption
- Empowering Local Stakeholders
 - Training modules for facility managers on data-driven decision-making
 - Peer-to-peer exchange sessions to share best practices across states

Ndili closed the interview by inviting listeners to register for the conference, noting that earlybird slots were filling fast. She stressed that the collaboration with WHX was more than a oneoff event—it marks the start of an ongoing ecosystem where ideas become pilot projects, and pilots scale into nationwide programs.

This radio conversation set the tone for a season of heightened public-private engagement in Nigerian healthcare—one that aspires to deliver measurable improvements in access, quality, and sustainability.

During the meeting, Mrs. Ndili also provided updates on key policy advocacy efforts and legislative bills currently sponsored by HFN, reinforcing the organization's commitment to shaping an enabling environment for healthcare growth. Mrs. Chinyere Okorocha, Publicity Secretary of HFN, was also present at the meeting. The discussions concluded on a strong note, with NBA-SBL pledging its support toward resolving high-impact legal and regulatory challenges affecting Nigeria's healthcare sector.

Both organizations emphasized their shared vision of driving sustainable reforms and strengthening the legal framework governing private healthcare operations in the country.

The 2025 Healthcare Leadership Conference, hosted by the Healthcare Federation of Nigeria in partnership with WHX Lagos, convened system leaders on June 2 at Lagos's Landmark Centre under "Accelerating UHC and the theme Health Sovereignty." Niide Ndili, HFN President, opened by underscoring the private sector's critical role in bridging Nigeria's health-system gaps-highlighting past wins from COVID-19 response to tariff waivers on pharmaceutical ingredients-and announced Olufemi Akingbade FNCS as HFN's new Executive Secretary.



Senator Dr. Ipalibo Banigo's keynote framed public-private integration as essential, calling governments to evolve into "dynamic enablers" and spotlighting successful insurance inclusion models and digital-health incentives. Mrs. Bola Adesola, HFN Board Chair, stressed that over 90% of Nigerian health spending is out-of-pocket, advocating expanded health insurance, rural telemedicine, and stronger regulation to safeguard quality. Presentations painted a digital-first path to UHC. Yale's Kaakpema Yelpaala laid out a roadmap for mobile-health and AI-driven diagnostics, emphasizing infrastructure investments and localized language models. World Bank's Olumide Okunola championed service-based Kenya-over PPPs-citing Peru and costly infrastructure deals. Dr. Adedamola Dada non-negotiable, argued that quality is WHO's introducing seven care-quality dimensions and urging performance-linked financing. Dr. Nkata Chuku proposed group practices to replace fragmented solo clinics, while Senator Dr. Ibrahim Oloriegbe detailed NHIA Act reforms to expand risk pools and fund vulnerable groups.

A closing panel on "Bridging the Public-Private Divide" reinforced calls for legal stability in PPPs, community-driven "Adopt-a-PHC" models, and the creation of pharmaceutical hubs to cut production costs. Action items ranged from mandatory insurance enforcement and tax incentives for local drug manufacturing to digital-health sandboxes and diaspora engagement. The conference concluded with a unified call to dismantle silos, scale proven innovations, and co-create a self-sustaining health ecosystem that delivers equitable care to all Nigerians.

HEALTH ETHICS AND LAW CONSULTING HEALTH SYSTEMS' LEARNING WEBINAR ON IMPROVING EMERGENCY CARE PROVISION IN NIGERIA.

DATE: JUNE 19TH 2025



The Healthcare Federation of Nigeria (HFN), through the active participation of its 2nd Vice President, Dr. Jennifer Anyanty, who represented the President of HFN, Mrs. Njide Ndili, Country Director, PharmAccess Nigeria, joined key stakeholders at the Health Ethics and Law Consulting webinar focused on improving emergency care provision in Nigeria.

Held under the theme "When Minutes Matter: Implementing the Law on Emergency Care in Nigeria," the virtual session brought together thought leaders and health advocates to examine the practical challenges and solutions in delivering timely emergency medical services.

Speaking during the webinar, Dr. Anyanty emphasized the critical role of the private sector in bridging the existing gaps in emergency healthcare.

She reiterated HFN's commitment to advocating for stronger policy implementation, enhanced funding, and strategic public-private partnerships that can ensure lifesaving care is delivered when it matters most. Key insights from the session underscored that, while the government is introducing important initiatives, Nigeria's low health expenditure remains a major bottleneck. The need to prioritize funding for emergency services was echoed by all stakeholders.

Furthermore, the webinar highlighted the importance of adequate infrastructure, continuous capacity building for the health workforce, and the integration of technology as essential components for improving access and quality of emergency care.

Dr. Anyanty noted that HFN will continue to engage with stakeholders to champion reforms that make emergency healthcare more responsive and equitable, in her words, "The Nigerian patient is worth it."



NHFRA BILL PASSES FIRST READING IN NIGERIAN SENATE



A significant stride has been made toward strengthening Nigeria's healthcare system: the National Assembly has officially passed the National Healthcare Facility Regulatory Agency (NHFRA) Bill through its First Reading in the Senate.

This landmark legislation was informed by expert recommendations from a multistakeholder committee led by the Healthcare Federation of Nigeria (HFN). It proposes the creation of the NHFRA—an agency that will introduce unified standards for regulating healthcare facilities nationwide.

HFN applauds the quality of the policy documentation emerging from the Working Group and calls on its members to tap into the expertise and innovation of private sector actors, especially in areas of cancer care and nuclear medicine.

As the country moves forward in its fight against cancer, HFN stands poised to contribute its voice, resources, and partnership to build a resilient, inclusive healthcare system for all Nigerians.
